Minutes, General Meeting, Saturday 10/24/92

The meeting was called to order at sunset on Saturday, October 24, 1992, by President Kevin Block with 14 members present.

Kevin welcomed all present and reviewed portions of the enclosed hand-out, "Dues Schedule and Paddlers Guidelines for 1993". He announced that there will be monthly meetings of the Board of Directors and that club decisions will be made by this Board. (Paddlers present received the handout at the meeting.)

Valerie Sinnott explained and detailed the 1993 Sponsorship Package.

Lote Sanderson presented and explained a fund raiser with Gift Books. These are sold for \$10 and raise \$5 for each book sold by the club. There is no "up front" money that the club must put out so this money goes directly to the club. Idea was unanimously accepted by all members present.

Sharon Saul reveiwed all other portions of the hand-out "Dues Schedule and Paddlers Guidelines for 1993". She also added that one of the assignments of loading and unloading will also be setting up of the tent.

Stewart Saul discussed offseason work parties. These will be held on Saturday, January 23rd and Saturday, February 13th, 1993. ALL PADDLERS WILL BE REQUIRED TO WORK ONE OF THE TWO! Things to be done during these work parties include:

1. Repair and refinish club paddles.
2. Refinish Nalu's gunnels.
3. Refinish Ke Kai's gunnels.
4. Repair or replace Ke Kai's ama.
5. Repair Hanale if club funds permit.

Also discussed were tentative goals for 1993 Racing Season. These include:

1. Presidents Day Race in Sacramento, February.
2. Catalina Race, August 21-22, 1993.
3. KOA Long Distance Season Races, April to August, 1993.
4. Akau Hana's Regatta and Long Distance Race.
5. Queen Lilioukalani Race, Kona Hawaii, Sept 1-8, 1993.

DUES SCHEDULE AND PADDLERS GUIDELINES FOR 1993

Returning Paddlers Dues Schedule - If you have not paid your dues from the 1992 season (Treasurer will notify you) they are due and payable no later than 12/1/92. If you do not pay them in full by that time you will not paddle after that time and your name will be listed on a non-paddling board on the side of the box.

New Paddlers and Returning Paddlers Dues for 1993 - New paddlers will pay \$60 after the 5th paddling session if they intend on joining the club. They will pay the remainder of their dues (\$60) by March 15, 1993 or thirty days after joining, whichever comes later. Returning paddlers will pay \$60 on January 15, 1993 and March 15, 1993. If any would like to make payments (but meet those deadlines) make arrangements with the Treasurer.

Race fees (\$3 per race) will be collected each week. Long Distance fees and other fees will be scheduled according to what races the club decides to take part in. ^{**}The Steersperson will be responsible for the collection of fees and filling out of the necessary paperwork for each of the crews. That person can designate this job to others but will still be responsible. Those fees and paperwork will be turned in to Sharon no later than 8:00 pm on the Wednesday before a race. If it is not turned in then that crew does not race. There will be NO EXCEPTIONS AND NO EXCUSES!! You know this now, before the racing season and have plenty of time to get your crew together.

The Steersperson will be the main communicator between the coach and the crew. Coaches should only have to talk to one person and that person will be responsible to communicate to the rest of the crew. If you don't know about it ask your steersperson.

All crews will learn to rig, load, and unload boats. There will be an assigned crew to do this every week at regatta or other races. If its not done, TOO BAD! Crews don't race and you can blame the assigned crew.
