I. **Previous meeting minutes:** Approval of October meeting minutes will be postponed until the next board meeting.

II. Kudos

- III. **OSC Policy Update:** Lights are required on all canoes when paddling between sundown and sunrise. We have received complaints concerning the visibility of the canoes during dawn paddles.

IV. Treasurer's Report – Bob Darling

- a. We have spent \$5k more than we have taken it. This is mainly due to our purchase of Mākua Kane Dave in 2018. Most of the funds for that canoe were brought in at the end of 2017.
- b. We are \$300 under what we budgeted for donation income, excluding AmazonSmile and eScript. Including those we are closer to \$200 under.
- c. The club value is \$128k. This does not include the club store stock. Including the value of the club store the club value is estimated to be in the range of \$130k \$135k. This also does not include the value of Kai Malama Keiki which will eventually revert to us. We still are committed to raising \$6k \$8k for Jacob's Heart before ownership of this canoe reverts to us.

- d. We currently have 174 paid members, versus 122 members in 2016. This is a record for OSC.
- e. We exceeded our budgeted income from rec. paddle drop-in fees.
- f. The MBX accounting has changed since the last board meeting. After the latest accounting, profit from the MBX is ~\$1,660. Currently we have \$2,500 in reserve prize money for this race. Bob recommends adding money to the MBX prize fund. Forrest Monroy makes a motion to add \$1,100 to the MBX prize fund. Gayle Bensusan seconds this motion. All in favor; motion passes.
- g. The end of year party had a loss of \$171. We saved \$17 on awards.
- h. We have received tickets in the past from parking the trailer in the east harbor parking lot. Overnight parking is from 9pm to 4am. Since the trailer is always parked for longer than that we have to pay for two days of parking which is \$60. If this is not paid within 7 days the fee increases to \$40/day (\$80 total). We are considering ways to reduce this cost. One idea under consideration is loading the canoes in the west parking lot so that the trailer can be parked in its usual spot at no additional cost to OSC.
- i. Kay Miyamoto makes a motion to approve the treasury report. Phil Crowley seconds the motion. All in favor; motion passes.
- V. Equipment Duane Strong
 - a. The steering cables were replaced on the red OC1.
 - b. Makani Akua's iakos have been repaired and are being refinished.
 - c. The OC2 ama is being worked on.
 - d. We now have a platform for the double hull. Kay Miyamoto will store it.
 - e. We had two sets of lights that worked and one set that didn't. That broken set has been repaired. A small set of lights was purchased at West Marine. Four more sets recommended by Dave Waynar were bought. OSC now has lots of working lights.
 - f. Rich Vandine repaired some of the dollies.
 - g. We have a new set of bearings to be installed in a lowrider dolly.
- VI. Website Duane Strong
 - a. Signups were made for the steering class as well as a Turkey Day paddle.
 - b. A mailing list was created for the OSC newletter.
 - c. Fitness paddle signups were added.
 - d. A system has been set up for automatically emailing people when they pay membership dues.
 - e. Information on the lights requirement has been added to the safety page.

VII. Miscellaneous discussion

- a. The OC2 is being stored on Rich Vandine's small boat rack. We will pay him \$28/month for this rack space.
- b. Gayle B. suggests an increase to the junior race fee. Bob D. makes a motion to make the junior racer membership dues \$75, which would include sprint race fees but not long distance race fees. Kay M. seconds the motion. All in favor; motion passes.
- c. Pam M. makes a motion to increase the senior racer membership dues to \$125. Forrest M. seconds the motion. All in favor; motion passes.

- d. Pam M. feels like anyone organizing an event should be there from beginning to end.
- e. Pam M. believes she saw someone surfing a club OC1 at Cowell's. It is suggested that during small boat training we tell members that surfing club canoes is not allowed.
