Kay -kudos to Doug Evers for attending the safety committee as a resource and and attendees that come to the meeting who aren't board members; Gayle — Duane for putting a new lock on the shed and bulletin board that is in-closed; Leslie — to Kyle for driving us to the Sharks game and to Kim Sides for setting crews and workouts for Saturday March 24th albeit she is out of town; Tai — Yoko for helping the BOD with the reviving of the corporation; Theresa — Yoko, Tai, Phil for helping with the Corporation issue and Bob Darling and Kim for providing their records used when they were treasurer, Phil Crowley for helping make labels for filing; Phil — Yoko for helping the BOD with the tax issues and Theresa for all of her hard work and involvement as treasurer; Pam -Theresa for being an awesome treasurer and keeping track and doing all of the work involved and Tai for towing the canoes to Craig's in Watsonville for repair; Bob C. — Dave Waynar for chasing after the Tahitian canoe, Kyle — Tai for putting together the Sharks event; Duane — Tai for towing the canoes to Craig's in Watsonville for repair; Dave Waynar — to the entire board for ?

2. Protocol – Tai (5min)

A couple bullet points related to the Treasury. Who sets and enforces what policy. Only the Board sets and enforces policy. A wider latitude is given to the head coach in regards to the racing team, commitments and what canoes used during races. Other committees such as the safety and events Committee who do research and provide recommendations and are informational entities and the board makes the decisions. Executive committee — set up by board resolution who can set and enforce policy. Rule violation, Rule enforcement should be communicated through one person — The President of OSC — Providing a uniform presentation to the club members.

3. Treasurers Report – Theresa (10 min)

a. OSC Treasury Protocol

Regarding payment of membership dues -1. no one should be collecting membership dues except the Treasurer. If somebody does give another board member a check, the

check goes in the mail box in the shed immediately. Phil suggest that there be two options only. You pay online or mail to the P.O. Box. 2. – The only people that can make decisions regarding payment options are Theresa the Treasurer and Tai the President. Funds should not bypass the treasurer. The accounting system is complex and if money is spent outside the Treasurers knowledge, a detailed itemized list need to be presented to the treasurer for accounting purposes. Its not the coach's discretion on how funds are to be spent. Funds spent must be documented and approved by the Board. 3aa. Theresa is asking members to pay membership dues by check or cash in lieu of PayPal. Service fees cost is \$7 per person who pays via PayPal and OSC's expense was \$800 in service fees for 2017. Check and cash payments are preferred however OSC has factored in the cost of using PayPal based on the convenience factor. 120 paid members currently - 39 recreation, 74 race, 7 junior. Harbor rent has increased by 2%. And now that OSC has added additional canoes to its fleet the rent will increase more than what was originally budgeted. Based on the budget proposed its

presumed the budget will come out ahead \$3,500 - \$5,000 after the MBX. As of March 23, 2018, \$25,000 in checking account and \$8,000 in savings account.

b. Update on corporate status - Tai

For the State of California a Binder has been provided to include everything submitted this week. OSC's 2016 tax return, reviver application to revive our corporation, a registry of charitable trust. Turnaround time for each is possibly 90 days. Must have a Charitable Trust # before submitting the reviver application and tax returns before charitable Trust # can be issued. Cannot operate as a 503c nonprofit without a charitable trust #. An accountant was hired to assist OSC with the 2016 tax return due to income exceeding \$25,000. Also applying for our tax exempt status. The Federal has not suspended OSC's corporate status. To date cost are \$35.00, CPA - \$125.00 and \$40.00 penalty for 2016.

c. Next steps - Revive Corporation, Name Change, Sellers Permit

Change club name on a Federal level. Previous club name is still referenced on a Federal level. Obtain seller's permit for selling merchandise to avoid suspension of the corporation. Application process is involved and OSC must collect sales tax. For online purchase of OSC's merchandise, PayPal calculates the sales tax based on the city and county where purchased. Phil will research the cost involved to obtain a seller's permit and bring a proposal to the next board meeting.

4. Equipment Update – Duane (5min)

Derigged the double hull and rigged one Bradley canoe. Unrig Koholo and rig the Bradley canoe. Leave Koholo unrigged while Duane finishes repairs on the lakos. The Amas and lakos for the other 2 canoes are set aside until the canoes being repaired at Craig's in Watsonville return. And then we will rig.

RE: Proposed Safety Committee Recommendations and Requirement Hand Out.

(See Attached) Bullet Points – Under Huli Practice and Recommendations – Phil suggest it's a good recommendation weather permitting. Pam does not agree that a huli recovery be required to renew membership. She's in agreement that Huli procedure be discussed with the paddlers and confirm that the paddler can tread water before they go out. Tai suggest that a Safety Manual binder be available in the shed referencing the Safety recommendations. PFD Recommendations – Per Gayle, she cannot modify the NCOCA Waiver. Gayle did add an addendum referencing able to tread water for 30 minutes and if not, you must wear a PFD. To abide by our Code of Conduct and to list any specific medical conditions. Leslie recommends reporting incidents that occur during practices or races on an incident report. For example, a Keiki getting cut in the parking lot. Albeit minor, good practice to document. Blank incident reports will be in the safety manual binder in the shed. The safety manual will be available for all OSC crews. Leslie recommends that an email go out to the leaders of all Crews - Mom's Pirates, Racers and Recreational informing them of this Updated Safety Manual and the location in the shed. Attention all paddlers please be informed that there is now an updated Safety Manual located in the shed and on the OSC Website.

9. Coaches Corner – Dave Waynar

Major things/events that we want to accomplish that has been very time consuming. Currently 12 Master Men paddlers and 24 Senior Master Men paddlers. Average of 4 boats on the water during practice. And 2 – 3 canoes during morning practice 5:30am. 12 paddlers going to Hawaii this weekend March 31st- April 1st doing the channel crossing From Kauai.

a. New canoe Purchase (20min)

RE: See Attached Breakdown of Cost, Yearly Expenses for Tahitian V6 Racing Canoe & Current Outrigger Canoe Inventory. 2018 Repayment of \$16,000 in Loans by OSC racing members.

Per Dave W. Makani Akua is an outdated racing boat and the spray skirt. Pam mentioned there is a Bradley division. Per Dave all the racer men are not interested in racing Bradley's. They want to race Unlimited and competitive boats. Men's racing program — Total Men 55, 3 crews -21 Open Men = 3UL's, 1 + crews - 10-Master Men = 1 UL, 6-crews - 24 SM Men = 1UL. Total Crews — 10. Total UL's needed: 5 Dave brought the canoe up for the club to try out, paddle and give feedback. The men paddled it, the women paddled it.

Total Cost: \$27,500 (includes 2 sets of lakos laminated wood and carbon fiber, Ama and spray skirt. (SEE BREAKDOWN SHEET FOR ITEMIZATION of FUNDING FOR PURCHASE, FUNDRAISING EVENT, PREPAID 5 YEAR MEMBERSHIP – April 1, 2018 – April 1, 2022, 1K LOAN INTEREST FREE FOR 14 MONTHS, 5K LOANS INTEREST FREE FOR 14 MONTHS) TOTAL FUNDING AMOUNT \$27,950

b. Sale of Corporate Assets:

Sale of Maka Nui – Rhino. Not much opportunity to sell. However Kimokeo from Maui is interested in buying it and is also interested in purchasing the stryker. We are looking at what is our oldest and unused canoes. There are willing to pay \$5,500 for the Stryker and \$3,000 for the Rhino. Dave Suggest this as an avenue towards payment for the loans. Theresa reminded the board that Makani Akua is used for rec paddle and Shared adventures. Per Dave it's a utilization issue. An avenue to offset the loans and update our equipment. Tai asked if there is a canoe in need of repair soon and if so, possibly sell in lieu of repair? Per Duane, currently all the canoes are in good standing. Guy and Kyle gave Dave Kudos on his time and research on how to obtain the Tahitian Unlimited canoe. Gayle's concern is that \$7,500 is still owed to Jacobs Heart and now the possible \$16,000 loan. Dave reminded Gayle that the Jacobs Heart Canoe is his responsibility and that OSC has paid only \$4,000 and that \$43,000 has already been raised in the last 2 years towards the \$50,000 5 year Contract agreement with Jacobs Heart.

Kyle Motioned to accept Dave's proposal for funding through fundraising events, prepaid 5 year memberships, 1K and 5K loans, Duane 2nd the motion, Motion passes. 5 yays, 3 nays and 3 abstained.

SAFETY COMMITTEE RECOMMENDATIONS & REQUIREMENTS

(OSC BOD meeting 3/25/18)

OSC's Safety Committee purpose is to recommend and advise BOD towards compliance with paddling safety rules and regulations that substantially exceed the regulations required by the NCOCA and the Coast Guard.

Safety Manual – NCOCA requires a a Safety Manual to be kept on site; recommendations:

- Link created to online Safety Manual
- Online Safety Manual will be printed, stored in binder kept in file drawers in shed
- Online updates will be printed; put into manual

Documentation – NCOCA requires documentation to be kept in regards to paddlers on the water, float plans, incident/occurrence reporting. Recommendations:

- Spiral bound log book signed in by each paddler at time of arrival for any OC6 paddle; top of page has date, time paddle is starting, estimated time ending, float plan if known
- If leaving in a single OC6 or any small canoe, let someone/anyone on land know your plans (float plan) in regards to estimated time of return and destination; a text to 831-535-2971 is available for this purpose; let whomever the contact is, know when the canoe has returned
- Blank Occurrence/Incident/Accident Reporting Forms provided by the NCOCA will be kept in a folder within shed; use for anything from an occurrence (ie: keiki receives a minor cut on foot walking through parking lot) to a higher risk incident (ie: huli, swamping, surf, rocks, equipment involvement); information ideally is gathered within 72 hours; contact Safety Officer.
- Documentation of *OC6 use* outside of regularly scheduled groups is *noted on Club Calendar* via reservation process; documentation of use of small canoes is through an online sign-up.
- Bring awareness to existing online form titled "Questions, Suggestions, Concern?".
- Consistent web based tracking of updated waivers; work in progress

PFD's Recommendations:

- Add clause to waiver: "I have been informed that it is recommended I wear a PFD. I am waiving this option." (initials). Reason: PFD's are the #1 item that may keep you alive.
- Add clause to waiver: "I know I am responsible for insuring that I can tread water in 50-55degree ocean water for 30 minutes." (initials)
- OSC OCI/OC2 paddlers wear PFD
 PECOMMENDATION
- Over time, gradually *upgrade* type of PFD's

Aloha.

I am really proud to usher in the 2018 season as Outrigger Santa Cruz's Head Coach.

With this comes a lot of responsibility including continuing to build up both the men's and women's racing programs and bring OSC into the progression of the sport.

I am also will working to expand the youth program as well as help support all other aspects of the club including the recreational program.

I have an amazing coaching staff in place and we have brought on some really truly talented paddlers. We have 20 guys just in the Men's Open program itself. This is just one example of our growth which is a result of the continual progression in training and coaching.

With that progression, we are looking to progress our equipment as well.

We currently have 5-7 men's crews that we can put on the water at anytime with 3-4 of the crews able to race unlimited division. We have also increased the women's program substantially in teaming up with Pu Pu O'Hawaii. Unfortunately we only have 2 unlimited canoes.

We are working hard to add a 3rd Unlimited canoe. We have been trying out a top of the line Tahitian canoe. As Coaches and paddlers have been testing the canoe out and providing feedback, we are set on targeting the purchase of a new • Tahitian FAI Va'a 6 man racing canoe with all carbon fiber iakos and ama.

The canoe is far more stable than the Puakea yet in side by side comparison just as fast on the water. The canoes are designed to have a longer water line when weighted which helps the canoe track and allow the steersman to paddle 60-80% more than the Puakea.

The canoe is quicker to turn the Puakea and the ama is far more stable in the water.

The second reason for the prospective purchase is the following: Matt and I recognize that many of our racers have come from the recreational program at OSC. So we would like to be able to provide access to a Puakea Unlimited canoe on a consistent basis so that the recreational paddlers can get to experience the same benefits of paddling an Unlimited canoe vs a spec canoe. The unlimited canoe would be available for the rec program on each day they go out. Dave Dyc was an amazing paddler who always considered new paddlers as the core of

building any paddling club. So we believe the Makani Kane Dave Unlimited canoe would be perfect for achieving this goal.

We have already secured \$6K in sponsorship for the new Tahitian Racing canoe. But Matt and I wish to also ensure the club is financially secure for years to come while also bringing the club into the next stage of competitive progression.

We are looking for the following pledges and will present these to the Board on the 25th of this month for approval:

5 paddlers willing to pay \$1,000 up front for 5 years of OSC racing membership dues.

2 paddlers willing to pay \$5,000 as a loan to OSC for a 16 month term in exchange for club membership for 2 years and full 100% of \$5,000 repaid after 16 months.

We are currently just looking to see who would be in a place to help OSC in this goal. There has been no official decision by the Board to purchase the canoe, only the goal of looking into feasibility of being creative in working towards the purchase.

We would love to see this progression in our club happen for all paddlers and we feel that the goals we have set out to see come to reality will become a reality with your help.

Fundraising Event:

Saint Francis High School women's volleyball Team Building event:

Mike Ruben has secured prepayment for a team building event for a Women's Volleyball Team during the summer of 2018. The event will be staffed by paddlers in the OSC men's racing program. The event will be on a single day on the weekend and be ~ 3 hrs long. Club canoes will be used for the event and consist of dryland events as well as on the water paddling. The event coordinator is Mike Ruben and the liaison is David Waynar.

Paddling adventure auction:

On 3/24/2018, an auction for a paddling day for up to 16 guests auctioned for \$5K at a fundraising event for Saint Francis High School. The paddling event will take place during the summer of 2018 and will be staffed by the Men's Racing Program. The event will include but not be limited to: paddling and safety instructions, pre paddling events, paddling on the ocean, and post paddling events.

Prepaid 5 years racing membership:

All prepaid memberships will be for racers in the mens racing program and will be effective from April 1st, 2018 to April 1st, 2022. If the member leaves before that time, no reimbursement by OSC is required. A \$1,000.00 check for each 5 year prepaid member will be provided to the the Treasurer and a receipt will be issued to each member.

\$1K loan for 14 months

One men's racing program member will loan OSC \$1,000.00 with no interest for 14 months. Upon OSC Treasurer receiving the check in the amount of the loan, a receipt and promissory note will be issued to the lending member. OSC will pay the loan amount in full by August 1st, 2019.

\$5k loan for 14 months

Three OSC men's racing program members will loan OSC \$5,000.00 each with no interest for 14 months. Upon OSC Treasurer receiving the check in the amount of the loan, a receipt and promissory note will be issued to each lending member. OSC will pay the loan amount in full by August 1st, 2019. Each lending member will be compensated with 2 years racing membership at no charge. Membership will be active from April 1st, 2018 to April 1st, 2020.
